**II Review of the prior meeting minutes** was approved

**III Roundtable:**

1. Justin Wagaman, Choice/CPAA: We are working on the project selection for the Medicaid demonstration. We need to decide between now and June what projects we would like to work on for Pacific County and need to get a group together to make the selections. There is \$85 M to be disbursed to the seven counties over five year and it depends on the number of Medicaid clients in the area. The projects to choose from are Bi-directional Integration of Care, Community Care Coordination, Transitional Care, Diversion, Opioids Use, Reproductive Health, Maternal and Child Health, Chronic Disease Management, and Oral Health.
2. Stacy Michaelson, O3A & I&A: Relatives caring for a family member’s child can get support up to \$750 per year for necessities. We have some money available to use up before the end of our fiscal year in June. Legal Voice booklet is also available.
3. Bob Caetano, WBH: Willapa Behavioral Health will have an open house on May 12<sup>th</sup> from Noon to 3pm at both our North and South County offices. May is Mental Health Month. We have recently remodeled the upstairs of the Valley View Health Clinic.
4. Michele Buzzelli, TAC by Kelsey Hopstad: TAC Town Hall was the 26<sup>th</sup> of April. We had a great turnout with about 50 people there. On April 28<sup>th</sup> the Drug Take Back program collected 8 pounds of prescription drugs. May 13<sup>th</sup> is the After Prom Party open to any high school students attending the Prom and they can stay from 10pm-1pm.
5. Kelsey Hopstad, GHC: The open house “College Night” is tonight with representatives from the colleges in our region including Eastern, Clatsop, Grays Harbor and Evergreen. Career 911 Healthcare Fair will be May 12<sup>th</sup> from 8:30 am to 2pm at the GHC Riverview Education Center. Registration is required. I only have spaces for 60 students.
6. Bree Shinkle, PCYA: We are currently recruiting for AmeriCorps.
7. Lisa Farvour, Great Rivers BHO: Moving forward with the EMT in Grays Harbor County and the fact team should be up and running at the beginning of next month.
8. Aaron Gillies, CR-EDC113: Gravity program participated in the Raymond Town Hall on April 16<sup>th</sup> to spread the word around about our program. We are gearing up for the summer program. Gravity is a year round program and no summers off. Looking for new ways to keep the students engaged during the summer with interesting field trips.
9. Sharon Madrid, VVHC: Were able to hire a nurse practitioner for the Raymond and PeEll offices. She will be here in about 60 day and work 2 days at each office. We are still looking for another physician.

10. Kathryn Burr, CSN: Last month was Sexual Assault Awareness Month and Child Abuse Prevention Month. We placed 535 blue pinwheels in both Raymond and Long Beach to represent the number of cases of child abuse over the last three years in Pacific County with articles in the both Willapa Harbor Herald and Chinook Observer about CSN. We remodeled our office and hope to have the grand opening in June for the Child Advocacy Center and will send out invitations.
11. Sheri Blakley, DSHS: New Social Worker at DSHS
12. Marsha Stigall, DSHS: Joyce Prior took over supervising Social Services in Aberdeen and Sheri took over Joyce's position here. We have added a resource board in our lobby so if anyone has events that would benefit our clients, you are welcome to posted them to the board. We are starting a Work-First Board in Grays Harbor then here in Pacific to help remove some of the barriers that prevent our clients get employed.
13. John O'Lague, CCAP: CCAP got the contract for Grays Harbor, Thurston and Pacific County for the Senior Companion Program and I took over the program a month ago. Lori Valentine has been out in the area looking for volunteers to assists in the program.
14. Tim Russ, WHH: This is a great group and I want to thanks everyone for being here.
15. Cheryl Campbell, PCAP/CAC: I am the presentation today on the Parent Child Assistance Program. The CAC has four programs, PCAP, visitation program for parents, forensic interviewing, and classes to teach parents to be better parents.
16. Carole Halsan, WHH: We continue to recruit physicians and we may be getting a little closer. Dr. Dutkiewicz will be here for a visit soon. We will be hiring an ARNP or PA to help cover the patient load when Dr. Buben retires the end of June.
