III Roundtable:

- a Bonnie Ryan, NPCFB: We did not have our auction and dinner this spring. We have decided to do a raffle for a BBQ-Smoker. Drawing will be on Father's Day.
- b Erica Griffin, WBH: Opioid Summit coming up on July 26th in North County in the morning at the Community Center in South Bend and South County in the afternoon at Ilwaco High School.
- c Kathryn Staats, GHC/AmeriCorps: My next project will be October 5th Career Fair for High School Students.
- d Bennett Fairlie, CCAP/AmeriCorps:
- e Jaime Scoones, CCAP: Our grants will be reinstated in July so the office will be open three days a week Monday, Wednesday and Friday. I will also be working with AmeriGroup providing case management for individuals on Medicaid. We will be hiring someone to help these clients be more self-sufficient. Our new boss is making changes one how our clients are served and helping them be more self-sufficient for their future.
- f Bree Shinkle, PCYA: We are bringing a Trauma Stewardship Training by Laura van Dernoot Lipski on November 28th to North County. It is free to everyone. We are recruiting for AmeriCorps. We have 20 placements to fill.
- g Cheryl Campbell, Connections/PCAP: Our Parent Child Visitation Program has changed. Now we are allowed to talk with the parents at five of the visits and give them some help instead of just writing down what they see them doing wrong.
- h Rene' Hilderbrand, CPAA/Choice: We are doing our Medicaid Transformation Project and just released our RFP. We will have a virtual town hall on June 8th from 1 to 2pm regarding the RFP. The letter of intent will be due June 14th and response June 16th. If any agencies participated in the State Capacity Assessment, we are paying these agencies now. If you haven't registered in the payment portal, please contact our agency so we can make these payments. We are still recruiting for the consumer advisory committee. Must be over 18 and have been on or currently on Medicaid. Mileage to and from the meeting location and a stipend is paid. Meeting are monthly.
- i Melanie Leahy, DSHS:
- j Emily Popovich, TRL: Flyers were handed out for adult programs coming up in June. A calendar was handed out with all the kids program for the summer in Pacific County.
- k Sharon Madrid, VVHC: We have a community room available to non-profit at no cost or rent by others for events. We have openings for a dentist, medical assistant, temporary medical assistant and possibly a scribe position. A new doctor is coming in July.
- I Jennifer Mitchell, CSN: We have started a new process with our advocates. They are willing to come to an organizational meeting to provide an information presentation on

- our services and anything that our crime victims covers, elder abuse, child abuse and neglect, cyber-crimes, how to protect yourself, how to watch what your kids are doing online, financial abuse, exploitation of elders or anything that the your clients or employees sees that is going on. We will do this for a small or large group.
- m Lyndsey Owen, RHS/TAC: I will be doing a Presentation on the After Prom Party today. Upcoming events, we will be hosting a youth mental health first aid training on June 22 in Ilwaco at the extension office for Grays Harbor College through a partnership with Pacific County Piece of Mind. Gearing up for a safe summer with our youth.
- n Bob Powell, O3A: We are in the process in developing support groups in North and South County for family caregivers and relatives raising children.
- o Doug Sheaffer, O3A & I&A: We continue to do the Medicaid In-home Care program, Medicaid applications, Medicare Supplemental plans, Part D plans, Family Caregivers Support and Senior Legal Advice Clinic. We have recently hired a new Information Specialist in Raymond. We continue to look at different venues to let people know what we are about and doing. Our case load in Pacific County is about 200 to 300 clients.
- p Mary Goelz, PCHD: We have created a new team (Prevention Team) including different organization in the county that are focused on prevention work around youth which include the schools, ESD113, health department, counseling, TAC, PCYA, WellSpring. Working on a quarterly newsletter with programs happening in the county. We are also working on programs with the jail, general and mental health, MAT therapy, Narcan distribution with the Sherriff and Police Department, First Responders, CSN, CCAP. We are planning to bring Dr. Peterson with the Oregon ACES program to North County. We have been working with CSN for the Childrens Advocacy Center to purchase special equipment for sexual abuse investigation in our county.
- q Carole Halsan, WHH: We have all our physicians now. In 2014 I joined a group of small hospitals WRHPP group to HCA, Commercial Payers and CMS know we are small hospitals and any change in reimbursement can threaten a lot of the smaller hospitals. To bring in some money, we will be working on care coordination with ACH to help with discharge planning. We started the 340B program to generate revenue for the hospital and pharmacies. American Health is our vender and it has generated money.
